

SUPER CAR PROMO
THE RULES

In this document you will find all the rules and the basic requirements to participate to the Super Car Bonus Promo.

By participating to this promotion, you accept the terms and conditions established in this document, as well as the terms and conditions of the Member Agreement, of the Policies and Procedures document and the general terms and conditions established by Wor(1)d Global Network, to which this promotion is subjected.

In case of discrepancy with the standard terms and conditions established by Wor(1)d Global Network, these terms and conditions will prevail. Wor(1)d Global Network reserves, at its own discretion and without notice, the right to modify the terms and conditions of this promotion.

Participation rules

To participate to the Super Car Bonus and be eligible to receive a car, with the following conditions, the user must reach the President Millionaire rank during 4 commission periods.

Within the validity range of the promotion, according to the starting and ending periods of the promotion it will be sufficient that the user reaches the President Millionaire rank at least 4 times, but it's not necessary that they are consecutive.

At the end of the period of validity of the promotion, the Company will proceed to purchase the cars to be offered as prize within the terms of this promotion, according to the total number of the users who will have reached the participation and achievement requirements of the Super Car Bonus.

The Company guarantees high value cars (the categories will depend from the amount of the different taxes that the Company will have to pay) and will also reserve the right to purchase not totally new cars, that are in good conditions.

With this promotion, Wor(1)d Global Network is giving to the user a real title on the car.

In order to be eligible to receive the chosen car, the user accepts that the basic rules of ethical behavior will be respected towards Wor(1)d Global Network and accepts that the Company could require the subscription of a loyalty and non competition agreement.
